## Lake View High School Council Report - May 18, 2005

Lake View high School continues to improve academically. Next year ten new AP classes will be offered and Chinese will be added to the language curriculum, an option available at only four other Chicago high schools.

Lakeview is also becoming more competitive. Three students advanced to the city science fair finals. Two students won honors at the Regional History Expo. The chess team took 3rd place and beat Northside College Prep as well as Lane Tech.

Mr. Feaman, the principal expressed concern about the possible rezoning of the Lane Tech attendance area. This could impact Lake View through increasing the number of students by 200. He feels the present size of 1300 students is the maximum the facility and the faculty can handle efficiently.

Re-zoning would have a negative impact on the quality of education, student safety and neighborhood comfort. This process is ongoing, so neighbors who have feelings about the expansion of Lake View High School, are urged to contact Alderman Schulter and CPS president Arnie Duncan.

### Lawsuit filed by neighbors

Neighbors on the 4100 block of N. Greenview Avenue have filed a lawsuit seeking an injunction prohibiting the owners of 4136 N. Greenview from violating the 45-foot building line recorded with the 1890 plat of subdivision which created the individual lots and blocks that make up our community. The suit alleges that the owners of 4136 N. Greenview knowingly, intentionally and deliberately prepared plans with an intent to construct their house at least 25 feet within an area lying between the 45-foot building line and the street which "is to be forever kept free of buildings" according to the recorded plat which runs with the land.

In 1890 when the neighborhood was originally laid out, many of its blocks and lots were encumbered with such building lines which appear on your survey. North Greenview Avenue has building lines of 45-50 feet. Many of the side streets have 25 foot building lines. All of the building lines prohibit construction of buildings in the area between the building line and the street. These recorded restrictions create the setbacks that are evident on every street in the neighborhood and create the open and unobstructed air, light and views which are particularly evidence on North Greenview Avenue with its generous front yards and many oversized lots. The neighbors hope to protect the easement that is created by the building line for the benefit of the property owners encumbered by similar restrictions and the general public.

The neighbors will seek to have GWCA join as a party in the lawsuit to fulfill its by-laws which seek to develop and preserve an appreciation for the historical significance of the neighborhood and encourage preservation, restoration, and beautification of the neighborhood. Copies of the lawsuit and a status report will be provided at the June 13 GWCA meeting.

#### **City of Chicago Crime Statistics:**

City of Chicago has seen a 4.4% decrease in crime from 2003 –2004

The 19th district has seen a 5.9% decrease in crime for the same time period, however, burglaries are up 58% (from 34 incidents to 54 incidents) and Motor Vehicle Thefts are up 111% (from 9 incidents to 19 incidents) The Police Department has a "Burglary Mission Team" working our district, trying to reduce the number of burglaries.

## New Business: 4136 North Greenview Building Permit – 45 Foot building Line

The 45-foot building line which runs on both sides of the 4000 and 4100 block of North Greenview is being violated by the excavation at 4136 N. Greenview within 20 feet of the street. There are other buildings lines that run throughout the neighborhood on other streets. Alderman Schulter was notified of this action, and he is investigating a stop work order or pulling the permit which has already been issued.

However, according to "The Plat of Subdivision of Ashland Addition to Ravenswood", obtained by the adjacent landowner to the north, Melody Tate, (which includes the area from Irving Park Road to Berteau and from Clark St. to Greenview) was subdivided with the restriction that "The strip of land in each block of this subdivision lying between the Building line and streetline is to be forever kept free from Buildings." This plat was recorded April 15, 1890.

A request was made for a "Stop Work" order at 4136 N. Greenview. The owner said she is contacting her legal representative. A letter was sent to the owner on behalf of Ms. Tate and Mr. & Mrs. Desmond (owners of the adjacent property to the south). There has been no response to the letter.

#### The membership moved on the following resolutions:

Motion #1, Moved by Dale Petersen, seconded by Bob Flannery with all members present voting unanimously in favor:

"Resolution supporting the overlay of Building Lines per the Plat of Subdivision of Ashland Addition to Ravenswood", dated April 15, 1890, by Alderman Schulter.

Motion #2, Moved by Bob Flannery, seconded by Tim McGonegle, with all members present voting unanimously in favor:

"To support a request to the Alderman to place a "Stop Work Order" and to rescind the permit issued for 4136 N. Greenview Ave. as being in violation of the 45ft building line."

Motion #3, Moved by Carol Blalock, seconded by Bob Flannery, with all members present voting unanimously in favor:

"Encourage all GWCA members and neighbors to support all actions taken by the adjoining landowners to enforce the building line, by and not limited to: flyers and public relations, petition, testifying at hearings, and/or joining as a party to any lawsuit.

A meeting will be held on Monday, March 21, 2005 at 7pm, in the auditorium of Lakeview High School to address the situation and to learn of neighbors' reaction to the violation of the 45-foot building line.

The meeting adjourned at 8:58 pm.
