# Streetscaping Project for North Clark St.

A meeting was held Tuesday, February 1, 2005 at Chase Park, regarding a process to develop and implement a streetscaping plan for north Clark St. from Argyle south to Montrose Avenue (4900N to 4400N). Scott Waldinger, from the Chicago Department of Transportation presided, along with Dan Luna, from Ald. Schulter's office, as the Alderman was unable to attend. A representative from Ald. Shiller's office was also present but did not speak. Approximately 40 to 50 area neighbors were in attendance.

At present, the Clark St. project is "unfunded", but the plan is to utilize proceeds from the TIF (Tax Increment Financing) district that was created in 1999. Funds will begin accumulating due to new building development in the TIF district, and currently planned developments at the former Rainbow Skating facility (Lawrence and Clark) and the former Flash Cab facility (Leland and Clark) may be among the first to contribute. Disbursement of TIF funds would occur at some time in 2005, with design scheduled for 2006 and actual construction and implementation scheduled for 2007. Other funding options for streetscape projects include federal and state dollars, "General Obligation" bond funds, and developer money, although none of these sources is expected to be significant for this particular project.

The scope of the project is estimated to be \$3 to \$5 million depending on the size of the area and the elements that need improvement. Improvements in the other streetscape projects have included: New sidewalks and curbs, street resurfacing, including into side streets to the closest alley or 125 feet, new lighting, new "community identity" banners, new planters, new bicycle racks and new catch basins

Local residents will be needed "adopt" plantings including the actual plant purchases and ongoing maintenance. "Hardscape" improvements are maintained by the city. Mr. Waldinger stated that decisions about what exactly is done in each project are determined by the budget, combined with the wishes of the Aldermen and the wishes of the community. Two to three block increments are worked on at one time, and Mr. Waldinger stated that no streets would be closed during construction, but that traffic is diverted to side of the street when necessary.

Owners of buildings, who have "sidewalk vaults", would require a permit and have to pay a special fee to keep their building's access to these vaults.

It was continually stressed that this was a first information meeting, and that no decisions regarding design or implementation dates have been made.

A "question and answer" time then took place, with some questions as to whether it was premature to beautify an area that has not yet become a destination area. Others queried, "until current tenants of the "wholesale" companies decide to become involved, or until these types of businesses leave the area altogether, what's the point of the improvement?" Generally the reaction was favorable, however.

They will come pick up recycling in the neighborhood if there are enough neighbors who want to participate. GWCA participated with this organization before the blue bag program began. If you would like to improve the recycling in our neighborhood, let the GWCA board know. If enough neighbors express interest the board will investigate resuming pick up with the Resource Center of Chicago.

Schulter's office; 10 neighbors, representing GWCA, Ravenswood and other neighborhoods

#### <u>Subjects Discussed:</u> <u>Issue of the Homeless in the Precinct</u>

A neighbor reported a problem with homeless people sleeping in the vestibule of her building, located in the 4500 block of North Greenview Avenue. Police officer said that's it is a common occurrence for during cold months. Homeless people look for apartment buildings with unlocked vestibules. They then enter the buildings, head for the highest floor so that they're not easily seen, and sleep. Report any broken locks and make sure the vestibule doors close & lock behind you upon entering.

# Fire at 4211 N. Greenview Avenue on January 28, 2005.

The officers attending the meeting weren't on duty the night of the fire (1/28/05) and were therefore unaware of the incident. The Community Policing Office for the  $19^{th}$  District (312/744-5574), stated that their report called the fire as of "an undetermined nature" and was "non-criminal" in nature.

## CAPS Beat 1923 January

A CAPS meeting for Beat 1923 was held at Lakeshore Baptist Church on January 11th at 7 p.m. Seven police officers and 1 CAPS organizer were in attendance.

The graffiti problem in the neighborhood was discussed. No new incidents had been reported all month and patrols had been increased. Today, just before the meeting, a tagging incident was called in. The caller got the license plate number and police will follow up on it.

Some suspicious activity is being reported in Warner Park and Gardens. Police strongly suggest putting signage in the park which restricts park hours to daylight hours only. Park hours are currently posted until 9 p.m. The change in signage will make it easier for police to patrol the park.

An aggravated criminal sexual assault took place on December 28th at 2:30 a.m. in the 3700 block of N. Wilton.The victim was approached by the offender as she was entering her residence. The offender displayed a weapon and forced his way into the residence. Once inside, the offender robbed and sexually assaulted the victim.

#### Minutes of the December 7, 2004, 7:00 GWCA Membership Meeting Lake View High School Community Room

Minutes of the Nov. 8th meeting which were published in the newsletter were approved. Tim presented the GWCA Balance sheet for Dawn Ragan who could not attend the meeting. We have a balance of \$12,211.82. This year we had : Income : \$13,463.65; Expenses : \$14,055.79; Net Income : - \$592.14 Old Business:

The proposed 2004 - 2005 Budget was distributed for review and comment. The main changes were an increase

in the Newsletter publication Budget by \$500 to \$3000; an addition for the GWCA Night Party of \$3000; and an increase in the Halloween budget from \$250 to \$1000.

Re: Budget - Tim mentioned that we may want to increase our contribution to Warner Park & Gardens to help pay for snow removal, etc. in addition to our annual contribution and paying for all GWCA parties held there. Peg mentioned that the Ravenswood school is also within GWCA and we may want to contribute to their DARE program or another school program. Peg said that we may be able to get paper goods more cheaply in the future to help boost the budget. Comments were made re: where the \$7850 in donations comes from? GWCA saw 11K in 2004, expects to see 18K in 2005 ? Re: the 25th Anniversary of GWCA commemorative piece (4K), it was decided that we should form a committee who could identify various ways to commemorate the anniversary, list the cost of each and have the members vote on what is done. Ann Maxwell moved that the budget be approved, Terry seconded the motion, all members save one were in favor.

Tim suggested that the GWCA Board members explain expenses that they are responsible for in the budget at future membership meetings. Other items raised for discussion were the need to increase fundraising (with a specific purpose in mind), to draft the history of LVHS and include it on the GWCA website, contribute not only to LVHS but also to the Ravenswood School which is on the GWCA area also.

#### New Business:

**GWCA Board Member Nominations** - Debbie Frisch and Barb Sullivan were on the election search committee. Three members are retiring: Ann Bines, Debbie Frisch and Seri Porter. Three people were nominated for the positions : Jim Friestad, Dimitri Christopoulos and Carol Blalock. All were approved to the GWCA Board, no members opposed. Tim explained the role of the GWCA Board and thanked retiring members. The next Board meeting will take place on Jan. 10t<sup>h</sup> at 4117 N. Greenview, 7 PM. LVHS Tutor Program Volunteers - the volunteers will be formally recognized in the newsletter. All members are encouraged to get involved with the program.

**LVHS Foyer Improvement Request** - A request was made to GWCA to contribute to the LVHS Foyer Improvement plan. The LVHS Alumni Room has already been renovated by the Friends of LVHS to bring it back to the style of the period when the school was opened. The school asked for support from GWCA for the foyer improvement but no dollar amount has been requested. Tim raised the item for discussion. The cost will be several thousand dollars, it was suggested that GWCA contribute \$750. The motion was made by Peg and seconded by Sid to approve the \$750 donation for the LVHS foyer renovation.

**The GWCA caroling party** will be on Dec. 19th, starting at 6 PM, not 5 PM as was listed in the last Newsletter.
