**Restrictions:**

1. If Arterial Street Outside CBD, Then Start no earlier then 9:00 A.M. and end no later then 4:00 P.M.
2. If Non-Arterial Street Outside CBD, Then Start no earlier then 7:00 A.M. and end no later then 3:00 P.M.
3. Permittee must provide a sign which identifies the telephone number and company or person performing the work. Signage may be affixed to barricades.
4. No work in or use of the public right of way is to be done when a special event is taking place. It is up to the applicant to determine if an event is scheduled. To obtain a listing of programs or events within the City of Chicago please dial 311 when you are within the City boundaries.
5. Contractor must notify 811 Chicago at 312-744-7000 no less then 48 hours (exclusive of Saturdays, Sundays and Holidays) but no more then 14 calendar days in advance of the start of the excavation or demolition, unless the excavation date was provided with the application and remains unchanged. Prior to 26 calendar days the Contractor must notify 811 Chicago to renewal the dig date! It is the Excavator's responsibility to request refreshing of marks when needed, but no longer than 28 calendar days after the last requested date. When applicable, all excavation areas are to be clearly marked in safety white paint prior to calling 811 Chicago. White paint is not required for joint meets or emergency work. Excavators requesting dig tickets are responsible for the protection of utility markings at the job site. Any markings of underground utilities utilizing utility colors must be done by facility owners or authorized agents only.
6. A copy of the permit must remain on-site for inspector's review.
7. All work shall be in accordance with CDOT Rules and Regulations for Construction in the Public Way and City of Chicago Municipal Code. Work to be performed as per plans and specifications. All traffic control will be the responsibility of the contractor, and must comply with all CDOT and MUTCD standards.
8. Contractor must secure plating over all openings in the roadway and secure all sidewalk/parkway openings during non-working hours until such time when the road surface is restored.
9. Start Time no Earlier than End Time no Later than
